

Information governance

Main duties and responsibilities

1. Primary representative of student views to the University and to local, regional and national bodies.
2. Trustee of the Students' Union, which is a charity under the Education Act 1994 and Charity Act 2006.
3. Work within the UBU constitution, its governing documents and by-laws.
4. Enact governing documents, by-laws and policy.
5. Member of the UBU Executive reporting to UBU Council and UBU General meeting
6. Provides a student input by working with staff to ensure our student voice and activities meet the needs of students
7. Accountable for working towards manifesto pledges.
8. Maintain adequate awareness of other sabbatical officer activities.
9. Collaborate with other Sabbatical officers to ensure campaigns and events are relevant to the student body
10. Abide by the sabbatical code of conduct
11. Responsible for representing the interest of the student body in all academic matters of the student experience.
12. Work with the relevant UBU staff on gathering research and data on academic matters.
13. Work with the relevant UBU staff to ensure the election and training of Student Reps and Faculty Reps are met in line with UBU policies and procedures.
14. Chair the Academic Assembly, which is a committee made up of all the Faculty Reps.
15. Lead on academic-related decisions of the Students' Union.
16. Report regularly to UBU Executive and UBU Council on academic matters.
17. Work with relevant UBU staff on planning and delivery of awards for Representatives.

18. Be the default Sabbatical Officer nominated to sit on investigating committees for academic misconduct, fitness to practice panels and other disciplinary committees.
19. Report to University Learning and Teaching Committee on academic matters.
20. Responsible for representing the interest of students in University policies.
21. Be the lead student representative to the Quality Assurance Agency (QAA) and as such, to work with the institution facilitator during the QAA Higher Education Review (HER).
22. Main contact to the University regarding student surveys, including, but not limited to the National Student Survey (NSS), the Bradford Student Survey (BSS), the Post-Graduate Taught Experience Survey (PTES) and the Post-Graduate Research Experience Survey (PRES).
23. Main contact to Information Services (Library & IT Services) and represent the interest of students at Information Services meetings.
24. Main contact to the Careers Service, and represent the interest of students at Careers Service meetings.
25. Main contact to the Higher Education Funding Council for England (HEFCE).
26. Lead on NUS and non-NUS education campaigns.
27. As a Student Union Staff member to support the UBU reception rota.
28. As a Student Union staff member to support key student events through the year such as Freshers Week, Varsity, UBIES.
29. **As a University citizen supporting key student events throughout the year such as Open day, clearing, enrolment, graduation.**
